This cause coming on to be heard on Landowner Alliance's motion to stay, pending the resolution of this appeal, any implementation of the March 8, 2023, order entered by the Illinois Commerce Commission granting Grain Belt Express LLC a Certificate of Public Convenience and Necessity in the Commission's Docket No. 22-0499, captioned *Application for an Order Granting Grain Belt Express LLC, as a Qualifying Direct Current Applicant, a Certificate of Public Convenience and Necessity pursuant to Section 8-406(b-5) and 8-406.1 of the Public Utilities Act to Construct, Operate and Maintain a High Voltage Direct Current Electric Service Transmission Line as a Qualifying Direct Current Project and to Conduct a Transmission Public Utility Business in Connection Therewith and Authorizing Grain Belt Express LLC pursuant to*

Sections 8-503 and 8-406.1(i) of the Public Utilities Act to Construct the High Voltage Direct Current Electric Transmission Line, on the objections thereto filed by the Illinois Commerce Commission and by Grain Belt Express LLC, and the court being advised in the premises:

IT IS THEREFORE ORDERED that Landowner Alliance's motion to stay any implementation of the March 8, 2023, order entered by the Illinois Commerce Commission granting Grain Belt Express LLC a Certificate of Public Convenience and Necessity in the Commission's Docket No. 22-0499, pending the resolution of this appeal, is granted.
